### WEST COAST GOLF GROUP ANNUAL TRI-COURSE PLAYING PASS TERMS AND CONDITIONS

- This Pass is for a term of 365 days from the Start Date.
- This Pass is for a maximum of 120 rounds inclusive of all three sites per 365 day period. Once the 120 annual rounds are redeemed, Pass Holders will receive 50% off the posted green fee rate. No rain checks will be issued for pass holder rounds.
- Pass Holders will be charged for any No Show Rounds
- This Pass is solely for use by the designee only and is non-transferable and non-refundable. Any fraudulent use of a pass by a third-party will result in the immediate termination this agreement without refund
- Pass holders are eligible to play in member events (Clubs may exclude pass holders from participating in some events, at the club's discretion).
- Pass holders are not eligible to use Swan-e-set Member reciprocal privileges.
- Hazelmere Fitness Facilities and lockers are not included regardless of Primary Course selection.
- Annual Playing Pass holders will be billed monthly for their purchases to their account on the credit card provided. If a valid credit card is not on file, charging privileges will be suspended. Pass holders in arrears will have playing privileges suspended. (We accept only Visa and MasterCard for pre-authorized account payments).
- Annual Playing Pass holders who select Swan-e-set Bay Resort as their primary course will receive access to the members lounge, locker room and parking at Swan-e-set Bay. This primary course is subject to the Food minimums of \$180.00 for each period of January 1 to June 30 and July 1 to December 31, Men's and/or Ladies Club Annual Fees, Annual Hole in One assessment and Golf Canada fees. Swan-e-set range balls are available only to Pass Holders who choose Swan-e-set as their Primary Course.
- Any changes to the administration of the Pass including moving home course may be subject to a \$100.00 administration fee.
