### WEST COAST GOLF GROUP ANNUAL PASS TERMS AND CONDITIONS

- This Pass is for a term of 365 days from the Start Date and must be activated within 30 days of purchase.
- This Pass is for a maximum of 120 rounds inclusive of all three sites per 365 day period. Pass Holders will receive 15% off any additional rounds played during the term of the pass.
- No rain checks for pass holder rounds issued. No exceptions.
- Pass Holders will be charged for any No Show Rounds.
- This Pass is solely for use by the designee only and is non-transferable and non-refundable. Any fraudulent use of a pass by a third-party will result in the immediate termination this agreement without refund.
- Pass holders are eligible to play in member events (Clubs may exclude pass holders from participating in some events, at the club's discretion).
- Pass holders are not eligible to use Swaneset Member reciprocal privileges.
- Hazelmere Fitness Facilities and lockers are not included regardless of Primary Course selection.
- Annual Pass holders will be billed monthly for their purchases to their account on the credit card provided. If a valid credit card is not on file, charging privileges will be suspended. Pass holders in arrears will have playing privileges suspended. (We accept only Visa and MasterCard for pre-authorized account payments).
- Annual Pass holders who select Swaneset Bay Resort as their primary course must pay annual hole in one assessment of \$7.50 and Male Pass Holders will be charged Men's Club fees of \$80.
- Annual Pass holders who select Swaneset Bay Resort as their primary course may rent a locker in the locker room for \$144.00 plus GST for member locker room privileges, and may pay \$150.00 for up to two buckets of range balls per day/member range privileges, however Member Parking privileges are no longer available.
- Any changes to the administration of the Pass including moving home course will be subject to a \$100.00 administration fee.
